Subject: Extension of Corona Curfew in District Udhampur

ORDER

- 1) Whereas, necessary precautions regarding prevention and control of Corona Virus (Covid-19) infection have already been taken by the District Administration in coordination with Police and Health Departments; and
- 2) Whereas, it has been decided by the Government to extend the imposition of Corona Curfew, in order to restrict the movement of people, thereby limiting the chain of transmission
- 3) Now, therefore, in view of the above mentioned facts and in the interest of safety and wellbeing of the general public at large, I, **Indu Kanwal Chib, KAS, Chairperson, District Disaster Management Authority, (District Magistrate) Udhampur**, in exercise of the powers vested in me under section 144 CrPC, Section 34 of the National Disaster Management Act, 2005, in accordance with Section 2 of the Epidemic Diseases Act, 1897, do hereby order that the Corona Curfew imposed in District Udhampur till **07:00 am on 17/05/2021 (Monday)** is now extended and shall continue till **07:00 am on 24/05/2021 (Monday)** in the territorial jurisdiction of District Udhampur. The following activities shall be **permissible and non-permissible** during the said period of Corona Curfew--

(A) Permissible Activities

- i. All essential services shall be allowed to continue, both in the public and private sector.
- ii. Milk shall be allowed to open from 07:00 am to 10:00 am to ensure provisioning of essential supplies. **Fruit/Vegetable Mandi, Kallar shall be allowed to open on only Monday, Tuesday, Thursday and Friday from 5:00 am to 12:00 noon.** Fruit/Vegetable retail shops shall adhere to the same timing as allowed for Fruit/Vegetable Mandi.
- iii. **Grocery shops shall be allowed to open on 19/05/2021 (Wednesday) and 21.05.21(Friday) from 09:00 am to 02:00 pm. As requested by Market Associations the shopkeepers (other than grocery) are allowed to check the shops on Monday ie 17.05.21 wef 7am to 9am. Sale during this period is not allowed.**
- iv. CEO/EO Municipal Council/Committees shall regulate the mobile licensed rehries in the wards for the essential supplies so mentioned above, to avoid crowding in the market during the time so permitted.
- v. **Drug Control Officer Udhampur** in coordination with Chemist association shall regulate the opening and closing of the medical shops in the district. Diagnostic Centers, Clinical establishments, Petrol Pumps and LPG outlets shall be allowed to



- vi. There will be no hindrance to the smooth movement of goods and essential supplies, nomads migrating with herds and other products like agricultural / horticultural goods, on the National Highway and other routes of District.
- vii. There shall be no restriction on inter-district and intra-district movement of essential goods
- viii. Internet Services, IT, Telecom, Common Service Centres, IT enabled services sector including e-commerce are permitted
- ix. There shall be no restriction on the movement of Government Officials for attending office/ duties, on production of I-Cards/ Official Orders. **However, the attendance in the Government Offices is restricted to 50% on roaster basis except for the staff deployed for Covid related duties.**
- x. All Government Development/Construction works shall be allowed to continue without any hindrance
- xi. The **vaccination/sampling drives shall not be halted.** Localized mobile teams shall be constituted to provide vaccination in the residential areas and containment zones

(B) Non-Permissible/ Restricted Activities in entire District.

- i. There shall be a complete 'Corona' Curfew with no movement of people except for permissible activities only, as mentioned above
- ii. All Educational institutions already closed shall continue to remain closed.
- iii. All Shopping Complexes, Bazaars, Saloons, Barber Shops, Cinema Halls, Restaurants & Bars, Sport Complexes, Gyms, Spas, Swimming Pools, Parks, Zoos, etc, shall remain closed
- iv. **Religious & Social gatherings such as marriages, to be attended not more than 25 persons only, whether indoors or outdoors, and funerals / last rites to be , attended by upto 20 persons only.**

Since it is not possible to serve this order individually, it shall be circulated in print, electronic, radio and social media for information of all concerned.

Last but not the least, public at large is also being informed that **Section 51 of the Disaster Management Act** provides for penalties in case a person obstructs any officer or employee in discharge of his functions or refuses to comply with any direction given under this Act. Any violation of the above directions will, therefore, lead to prosecution under section 51 of the DM Act, 2005

Sr. Superintendent of Police Udhampur is requested to strictly enforce compliance to this order.
